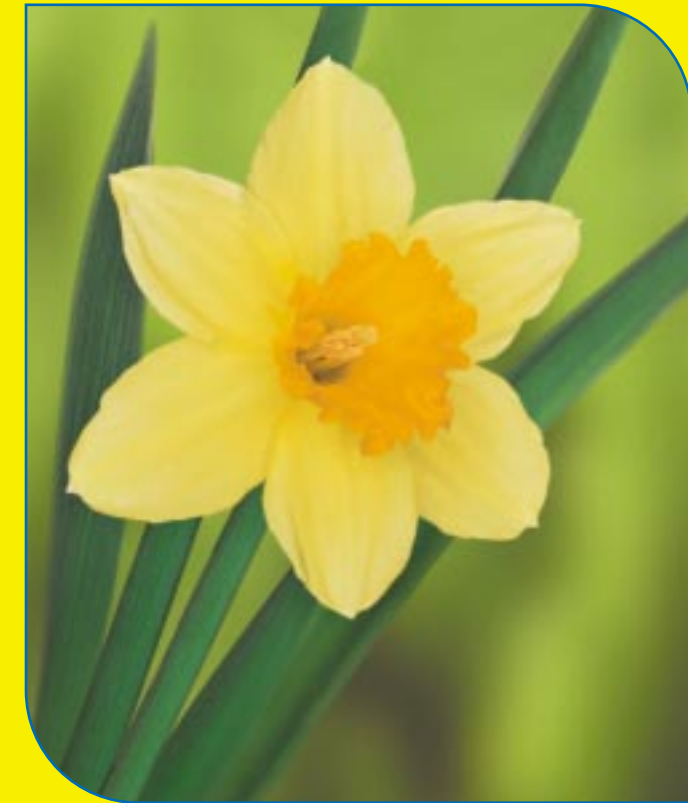

# What is Gift Aid?

Gift Aid is a simple, government initiative which allows us to increase the value of your donations at no extra cost to you. For every pound you give to us we can get an extra 28 pence from the Inland Revenue helping your donation go further to help cancer patients and their families.

During the next year if each donor said yes to Gift Aid we could raise an incredible extra £2 million to help cancer patients and their families – so you can see why your help is so important to us.

## How do I know if I can Gift Aid my donations?

The only condition is that you are a UK tax payer.

## How do I know if I am a UK tax payer?

If you have a salary, savings in a bank and/or building society, investments or a pension you may well be a tax payer, so you can Gift Aid your donations.

## What do I have to do?

All you have to do is complete a simple Gift Aid declaration which confirms that we can claim back the tax on your gifts. You can do this in one of three ways:

Complete the Gift Aid declaration found in this flyer and post it to us at the address provided.

## What does it mean to Marie Curie?

For every pound you give to us, we get an extra 28 pence from the Inland Revenue helping your donation go further. The table below shows the enormous difference this makes to us.

Your donation	Reclaimed tax at basic rate	Marie Curie receives
£1	£0.28	£1.28
£10	£2.80	£12.80
£20	£5.60	£25.60
£50	£14.00	£64.00
£100	£28.00	£128.00

## Will this affect my tax status?

No. As a tax payer any donations you make to Marie Curie have already had an element of tax removed from them, usually by way of income tax. What the Gift Aid scheme does is give back to us some of that tax as a boost to your gift.

## Do I have to tell the taxman about my donations?

Only if you are asked to complete a self-assessment tax form by the Inland Revenue.

## Can I Gift Aid my donations if I am a higher rate tax payer?

Yes. Please complete the declaration. You can then personally claim tax relief on the difference between your higher rate tax and basic rate on your self assessment form.

## How do I cancel a declaration?

All you need do is drop us a line at any time telling us you wish to cancel your declaration.

## Do company donations qualify for Gift Aid?

No. Companies can now claim all charitable donations as a deduction from their taxable profits. (Charities can no longer reclaim tax on company donations).
